These are the key accountabilities for the position.

- 1. Regulatory Compliance
- With the help of the RCPS team, continuously monitor any change in regulatory legislations and standards (such as EU regulations, US FDA, Chinese Regulations & Standards and national regulations) and customers' needs to update and develop ALBEA Policy and standards.
- Develop the expertise of our RCPS community within C&F PL in order to achieve excellence
- Provide leadership to manage and improve the Product Safety program within C&F PL to prevent liability and ineligibility of packaging material made.
- 2. Raw Material Leadership
- Develop the Standards that ALBEA C&F will have to follow for all the materials that ALBEA C&F procures
- Continue to develop and improve the systems to ensure with purchasing, R&D and a network of people within the plants that we receive the relevant information from suppliers
- Train the suppliers to understand ALBEA Product Safety and Regulatory Requirements.
- Manage the external documentation such as DOC from suppliers and NDA requested by suppliers.
- Be part of the Raw Material Approval process within C&F
- Manage and maintain the raw material taxonomy for raw materials and unique coding system of ALBEA.
- Ensure that any non-compliance concerning raw materials is identified.
- Lead, develop and manage the process of ensuring that Blacklisted Materials are eliminated.

3. Internal Training

- Ensure that the ALBEA C&F Team has the expertise to implement the PS Policy with a special focus on Raw Material compliance
- Lead and maintain a process of regular update of the ALBEA C&F product safety community on changes in compliance regulations, and the subsequent work required by ALBEA to comply with such regulatory changes.

- 4. Supplier Relationships
- Help the organisation to build the necessary relationships with the raw materials and components suppliers of Albea to help to drive the Responsible Packaging Program.
- Train with Procurement, Albéa's suppliers to understand ALBEA Responsible Packaging Program and to provide Albea with the relevant information.
- Be a key point of contact with ALBEA C&F's preferred suppliers to deploy our Responsible material strategy.
- 5. Customer and External Presentations
- Develop and present technical presentations regarding ALBEA capabilities, Product safety system and ALBEA Product Safety roadmap to customers.
- Participate to local or international seminars to position ALBEA C&F as a leader.
- 6. Product Development Support
- Cooperate with Product Development to select the right raw materials to comply with regulations or potential specific customer requirements.
- 7. Self-Development
- Keep current with business, leadership, and technology issue to provide functional leadership, direction, and assessment of business opportunities.

Accountability including KPIs

- Develop trust across ALBEA C&F so that where there are conflicting priorities or other issues are effectively managed to ensure that all involved understand the issues and agree with the solutions put forward.
